<b>Summary of duties:</b>			
Assists Baker by performing the simpler tasks involved in the baking of bread, rolls, muffins, biscuits, pastries, cakes, doughnuts, and similar items of food. Works under the direct instructions of higher graded baker. As directed, weighs or measures, and mixes ingredients by hand or machine for various baked products such as sugar, flour, yeast, syrup, and dough. Cuts dough into uniform portions. Adds fillings, places pans of dough into oven to bake, removes baked products from ovens, applies icings, and cuts cakes and pies for serving. Cuts, turns, or twists dough into specified products and fills baking pans with dough. Moves and distributes bakery supplies and products in and around production area of bakery. Checks production schedule to determine variety and quantity of goods to bake. Mixes ingredients to form dough or batter by hand or using electric mixer. Cuts dough into uniform portions with knife or divider. Molds dough into loaves or desired shapes. Spreads or sprinkles topping, such as jelly, cinnamon, and poppy seeds on specialties. Places pans of dough in proof box to rise. Inserts pans of raised dough in oven to bake, using peel. Adjusts drafts or thermostatic controls to regulate oven temperature. Removes baked goods from oven and places goods on cooling rack. Tests products during baking by touch or visual examination. As directed, adjusts measurements and revises recipes to improve taste, change quantities, adjust for altitude and humidity, or conform to special diet requirements when required. Utilizes health, safety, and sanitation practices, procedures, rules, and regulations to maintain a safe and clean bakery area and baking utensils. Uses and maintains hand and power tools and utensils of the baking trade such as rollers, sifters, grinders, cooking vats, proofing boxes, rotating ovens, mixing machines, roll dividers, rounding and molding machines, pie rollers, and bread slicing machines. Performs other related or incidental duties as assigned.			
<b>Basic Qualifications:</b>			
Qualification requirements emphasis is on the quality of experience, not necessarily the length of time. Although a specific length of time and experience is not required, you must show through experience and training that you possess the quality level of knowledge and skill necessary to perform the duties of the position at the level for which you are applying. Although a specific length of training and/or experience is not required, applicants must have sufficient training and experience, paid or unpaid, of sufficient scope and quality that fully provides the ability to perform the full range of duties of the position.
